Background: Call To Action

- 50 percent of all deaths occurred before the Somalia famine was declared in July 2011
- Integration of food security, nutrition, water sanitation and hygiene and health interventions
- Focus on gender dimensions and engagement with the affected communities
- 1st category of bottlenecks; joint
 - Information
 - Planning, prioritization and programming
 - Minimum capacity for national partners
- 2nd category of bottlenecks; influence on enablers
 - Access and humanitarian principles
 - Actively address emergent issues related to logistics/access, risk and multisector programming
